Earnest money should be deposited by receipt of Treasury Chelan/Deposit at call receipt of a scheduled bank/Fixed Deposit receipt of a scheduled bank/Demand Draft of Scheduled bank and submitted along with the application requesting the tender schedules. The Earnest money should be drawn in favour of the Commissioner, Thirunallar Commune Panchayat. If the opening day of tender happens to be a public holiday the same will be opened on next working day.

The tenders of the contractors who do not deposit earnest money in the prescribed manner will be summarily rejected.

The contractors should quote the rate on consideration of VAT as applicable.
