GENERAL RULES AND DIRECTION

1. The tender documents from the office of the Assistant Director, Tourism Dept, Karaikal on payment of Rs.100/- (Rupees one hundred only) and also can be downloaded from the official website (<http://Karaikal.Gov.in>).
2. The tender schedule will be issued to eligible Contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works.
3. Tenders, which should always be placed in sealed envelope, with the name of work written on the envelopes, will be received by the Assistant Director, Tourism Department, Karaikal up to 3.00 P.M on 31-12-09 and will be opened by him or his authorized representative in the Collectorate on the same day at 03.30 P.M.
4. Earnest Money Deposit of Rs. 2,000/- (Rupees Two Thousand only) should be given by way of Demand Draft of a Scheduled Bank issued in favour of the Assistant Director, Tourism Department, Karaikal.
5. Two cover system will be followed for the participation in this tender. The first cover should contain the Demand Draft for the Earnest Money Deposit of requisite amount and required certificates of their eligibility for having done similar works during last five years. Those who are downloading the tender schedules from the website should enclose the Demand Draft towards the cost of the tender schedule in addition to the DD for EMD and experience Certificates in the first cover. The second cover should contain only the filled up tender schedule.
6. Both the covers should be closed and sealed. The first cover should be superscribed as , "DD towards EMD and experience certificates" and the second cover as "Tender Schedule for Sound and Light System".
7. The successful bidder should provide the Sound and Light Systems as required by the Assistant Director of Tourism.
8. The competent authority on behalf of the President of India does not bind himself to accept the lowest or any other tender and reserve to himself the authority to reject any or all the tenders received without the assignment of any reason. The tenders which do not fulfill any of the prescribed condition or any condition including that of conditional rebate is put forth by the tenderer shall summarily be rejected.
9. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
10. The competent authority on behalf of the President of India reserves to himself the right of accepting the whole or any part of the tenders and the tenderer shall be bound to perform the same at the rate quoted.
11. All works proposed for execution by contract will be notified in a form to tender pasted in public places and signed by the officer inviting tender or by publication in news papers as the case may be.
12. All rates shall be quoted on the tender schedule. The amount for each item should be worked out and requisite totals given. Special care should be taken to write the rates in figures as well as in words and the amount in figures only, in such a way that interpolation is not possible. The total amount should be written both in figures and in words.
